Final Authorisation on Marina Fees and Charges for Copra Shed Marina

1. Pursuant to Section 4 and Section 41 of the Fijian Competition and Consumer Commission Act 2010 and the Fijian Competition and Consumer Commission (Control of Prices for Marina Management Services for Passengers on Commercial Ships and Cargo Transportation) Order 2018, FCCC makes the following Authorisation on the marina fees and charges for Copra Shed Marina.

Citation and commencement

2. This Authorisation may be cited as Final Authorisation for Marina Fees and Charges by Copra Shed Marina and is effective from 27 March 2018.

Maximum prices

- **3. (a)** The prices set out in Schedule 1 herein shall be the maximum rates applicable, as the case maybe, at which the goods and services mentioned therein may be supplied as listed in Schedule 1.
 - **(b)** No new charges shall be levied unless authorised by FCCC.
