Authorization of Marina Fees and Charges for Vuda Marina

1. Pursuant to Section 4 and Section 41 of the Commerce Commission Decree 2010 and the **Commerce (Control of Prices for Marina Management Services for Passengers on Commercial Ships and Cargo Transportation) Order 2015**, the Commission makes the following authorization on the marina fees and charges for Vuda Marina.

Citation and commencement

2. This Authorization may be cited as Final Authorization for Marina Fees and Charges for Vuda Marina and is effective from 28 September 2015.

Maximum prices

3. (a) The prices set out in Schedule 1 herein shall be the maximum rates applicable, as the case may be, at which the goods and services mentioned therein may be supplied as listed in Schedule 1.
- (b) No new charges shall be levied unless authorized by the Commission.


Conditions to this Authorization

4. This Authorization applies to Local Commercial Operators and Commercial Users in Fiji only.


Expiration of the Authorization
