FINAL DETERMINATION ON REVIEW OF SPECIFIC CHARGES IN SCHEDULE 2 OF THE 2009 APPROVED TARIFF OF FIJI PORTS CORPORATION LIMITED (FPCL)

Date of Report: 8th October 2010

1.0 INTRODUCTION

- 1.1 On 22nd September 2009 the Fiji Commerce Commission referred to as "Commission" hereafter made a final determination on Tariff increase for Fiji Ports Corporation Limited.
- 1.2 On 22nd October, 2010 the Commission received and accepted an application from Fiji Ports Corporation Limited (FPCL) for the review of specific charges in Schedule 2 of the 2009 approved Tariff.
- 1.3 The FPCL in its request to the Commission asked for specifically three charges in the approved schedule 2 tariff to be re-looked at to ensure the viability and profitability of the stevedoring company, Ports Terminal Limited (PTL , a 100% subsidiary of Fiji Ports Corporation Limited (FPCL) ,a Government Commercial Company.
- 1.4 Based on the submission received the Commission proceeded to analyse the submission and make a determination.

2.0 LEGAL FRAMEWORK

2.1 The Commerce, (Control of Prices for Ports and Marina Management Services) Order 2010 empowers the Commission to control/regulate the prices or rates for the supply of all parts and marina management services in Fiji.

3.0 ANALYSIS OF INFORMATION SUBMITTED BY FIJI PORTS CORPORATION LIMITED

- 3.1 In its submission to the Commission, FPCL provided Tariff Review Report prepared by Ernest and Young to undertake a review of the 2009 approved tariff.
- 3.2 The three specific charges FPCL wanted the Commission to re-look at were:
 - Full Containers (TEU¹ and FEU²)
 - Empty Containers (TEU and FEU)
 - Transhipment Containers (TEU and FEU)

¹ TEU-Twenty Equivalent Units

² FEU-Forty Equivalent Units

3.3 The FPCL also proposed to the Commission four (4) options for the proposed new tariff rates. These are;

Option A

Fifty Percent (50%) increase in Full Container charges (based on 2009 approved rates), 200% in Empty container charges and 100% increase in Transhipment Container charges.
