**Interim Authorisation on Marina Fees and Charges South Pacific Marine Pte Limited and its operating subsidiary companies**

Pursuant to section 39 and section 41 of the Fijian Competition and Consumer Commission Act 2010 and the **Fijian Competition and Consumer Commission (Control of Prices for Marina Management Services for Passengers on Commercial Ships and Cargo Transportation) Order 2021**, the Fijian Competition and Consumer Commission hereby makes the following authorisation.

***Citation and commencement***

1. This Authorisation may be cited as Interim Authorisation for Marina Fees and Charges by South Pacific Marine Pte Limited and its operating subsidiary companies and is effective from **10 May 2023**.

***Maximum prices***

2. (a) The rates set out in Schedule 1 herein shall be the maximum rates applicable, as the case maybe, at which the goods and services mentioned therein may be supplied as listed in Schedule.
- (b) No new charges shall be levied unless authorised by FCCC.

3. The following conditions apply for the purpose of this Authorisation:



- (a) This Authorisation applies to Foreign Yachts and Local Private Yachts operators and Users in Fiji; and
- (b) South Pacific Marine Pte Limited and its operating subsidiary companies is required to make a submission to FCCC in one (01) years' time based on the information required by FCCC to make an informed decision on the actual rates that need to be set to allow equitable returns to South Pacific Marine Pte Limited and its operating subsidiary companies and affordability to consumers.

### ***Expiry of this Authorisation***

4. This Authorisation shall remain in force until **10 May 2024** unless earlier revoked, amended, or varied by the Commission.
