**Fijian Competition and Consumer Commission (Price Control) (Food Item Prices) Order
2021 (Legal Notice No. 97)**

1. Pursuant to Section 41 of the Fijian Competition and Consumer Commission Act 2010 (FCCC Act 2010) and **Fijian Competition and Consumer Commission (Price Control) (Food Item Prices) Order 2021**,

Citation and commencement

This Authorisation may be cited as Authorisation of Prices N0: 20221077 - for the item, Agricom (Fiji) Pte Limited, Farmers Best Full Cream (36 x 250g) is effective from Saturday 24th of December 2022
Maximum prices

2. The prices set out in the Schedule herein shall be the maximum retail and wholesale prices, as the case may be, at which the goods mentioned therein may be sold in the area so specified in the Schedule.
3. Where specified quantities as listed in the Schedule are not available or a new quantity is introduced in the market, proportionate prices MUST be applied to all other quantities pursuant to Section 50 of the FCCC Act 2010.
4. Where the product(s) listed in the Schedule will also be sold in wholesale quantities, the wholesaler must provide a copy of this Authorisation to the buyer or alternatively the buyer will need to seek price authorisation from the Commission under Section 41 of the FCCC Act 2010.
5. This Authorisation supersedes all previous prices authorised by the Commission for the said products listed in the Schedule.
6. This Authorisation shall remain in force unless earlier amended, varied or revoked by the Commission.
7. It is an offence for a trader to sell price-controlled goods and services without price Authorisation from the Commission under Section 41 of the FCCC Act 2010.
