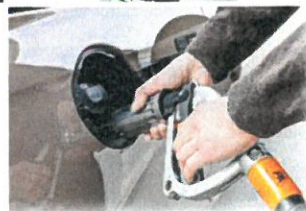

Authorisation of Prices for the Supply of LPG in Fiji

Interim Authorisation of Prices for the Supply of LPG in Fiji

1. Pursuant to Section 41 of the Fijian Competition and Consumer Commission Act 2010 and the **Fijian Competition and Consumer Commission (Control of Prices for Supply of LPG in Fiji) Order 2018**, FCCC hereby makes the following authorisation effective from **26 October 2018**.

Citation and commencement

2. This Authorisation may be cited as Interim Authorisation of Prices for the Supply of LPG in Fiji and is effective from **26 October 2018**.

Maximum prices

3. (a) The prices set out in Schedule 1 to Schedule 4 herein shall be the maximum retail and wholesale prices, as the case may be, at which the goods mentioned therein may be sold in the area so specified in the schedule. Furthermore, where the maximum price of an item listed in the schedules is required to be rounded up by reason of cessations of one (1) cent and two (2) cent denominations, the consequential increase in the price of that item does not constitute a contravention of this determination.

(b) For Bulk Gas, the prices have been set as Ex-Factory prices and the suppliers can add a reasonable (market determined) freight and delivery charges.

Schedule 1

4. The prices set out in Schedule 1 are the maximum retail or wholesale prices, as the case may be, at which the goods specified in it may be sold on the Island of Viti Levu and Vanua Levu.

Schedule 2

5. The prices set out in Schedule 2 are the maximum retail or wholesale prices, as the case may be, at which the goods specified in it may be sold on the Outer Islands and any area not mentioned in Schedule 1 and Schedule 3.

Schedule 3

6. The prices set out in Schedule 3 are the maximum retail or wholesale prices, as the case may be, at which the goods specified in it may be sold on the Island of Taveuni for LPG delivered out of Vanua Levu.




7. The prices set out in Schedule 4 are the maximum retail or wholesale prices, as the case may be, at which the goods specified in it may be sold on the Island of Rotuma for LPG.
